## All Level Information

NYS Corrections Law allows law enforcement to make community notifications on Level 1 by zip code only. Community notifications on Level 2 & 3 offenders will include the offender's exact street address. You may access offender information on the New York State Offender Registry Website at <a href="https://www.criminaljustice.ny.gov">www.criminaljustice.ny.gov</a>.

- \*Level 1 offenders include name, date of birth, photograph, residence zip code, along with offense description and special probation or parole conditions. They are not listed in the Sex Offender Subdirectory on the Division of Criminal Justice Service public website.
- \*Level 2 & 3 sex offenders will have the same above information and are included in the Sex Offender Subdirectory on the Division of Criminal Justice website. The exact residence of level 2 & 3 offenders will be listed. Employee addresses (if available) will also be listed.

To inquire about specific offenders, you may contact the New York State Division of Criminal Justice Services Sex Offender Registry at 1-800-262-3257. You must supply the offender's name, as well as another piece of identifying information such as a date of birth, address or social security number.

# Offender Details Domiciled

The information contained in the Sex Offender Registry through eJusticeNY should not be shared with the public. Unauthorized release of Registry information is a crime. Anyone who uses this information to injure, harass, or commit a criminal act against any person may be subject to criminal prosecution.
